Epic? In Our Lifetime—Never!

Saturday, March 23, 2019

Now that things have slowed down a bit, here is what amateur radio operations were like during the March 2019 Flood in Fremont.

It started out on Wednesday, March 13, 2019, in Dodge County Emergency Manager Tom Smith's office in the Dodge County Courthouse in Fremont, with the two of us discussing the situation. I was there to provide him weather information, via the National Weather Service (NWS), and to set up amateur radio communications support for him. The morning rainfall report, with several Hams contributing information, had shown that around ½ inch of rain had fallen on the snow, with over an inch in the Hooper area due to a report from the automatic gauge operated by Carl, N0YUV.

The Thursday, March 14 rainfall report showed that ½ to ¾ inch of additional rain had fallen. Tom Smith requested two additional amateur radio operators. I turned that duty over to other Fremont operators and concentrated on weather support. It was apparent that this was going to be a major flood operation, so Tom and I moved to the meeting room in the Fremont Police Department and he set up the Dodge County Emergency Operations Center (EOC). This turned out to be an excellent move because there are several phones, emergency power, WiFi, and is adjacent to the 911 Communications Center for Dodge County.

Mel, K0VLA and Steve, WB0VNF were the two additional Hams that I called for assistance. K0VLA set up and operated the OMMRS equipment at Methodist Fremont Health. WB0VNF went to the Lutheran Church shelter on East Military. He was relieved in the afternoon by Frank, K0AJA. Joe, N0XAT was mobile and sent us pictures and reports of the flooding. Jim, KB0DYU also sent us reports as did Dan, W7UP. I was using the automatic rain gauge run by Geri, N5RIG, who also sent reports.

On Friday, March 15, K0VLA was at the EOC at 7 AM, having been asked to go there by the CAP. I joined him at 10 AM. Operations in the field continued with WB0VNF coordinating the placement of the volunteer Hams. Larry, K0SW and Sharon, KB0TVB joined us for 2 days at Clarmar School for the Volunteer Registration Center. Mac, W0UVQ was able to assist them there.

PIONEER AMATEUR RADIO CLUB MINUTES FOR FEBRUARY 28, 2019

HOSPITALITY: Sharon Martens, KB0TVB sent a thank you card to the family of Dave Bauer, N0LGU for \$50 from his family in his memory.

EDUCATION: Jane Mehaffey, KB0ZUN had nothing to report.

FIELD DAY: Scheduled for Izaak Walton League Park in Fremont on June 22-23, 2019. Don Renze, K0OM Chairman.

FLEA MARKET: Scheduled for North Bend on July 13, 2019. Chairman Rich Mehaffey, KB0ARZ. He passed around a multi-meter which will be one of the prizes. The main prize this year will be cash. KB0TVB moved that \$350 be allocated for prizes, a \$200 prize, a \$100 prize, and \$50 for small prizes. K0OM seconded the motion, which passed. There will be a Silent Auction again with Steve Narans, WB0VNF in charge.

PICNIC: Scheduled for Sunday, September 22, 2019 at the Theophilus home. Dave Theophilus, W0NRW and Sharon Martens, KB0TVB Chairpersons.

CHRISTMAS PARTY: Linda Kirchmann, W0ZIP Chairperson asked if everybody was happy with the Outer Limits in Valley. They were so she will go ahead and set up a party.

NET MANAGER: Mel Cunningham, K0VLA thanked everybody. He has 4 Net Control Operators. He would like to see more check-ins. He said that he would need a Net Control for March 27 during Spotter Training. *(Spotter Training was later canceled due to the flooding.)*

ARES: W0NRW said Spotter Training would be in Scribner on March 27 at 7 PM. *(Spotter Training was later canceled due to the flooding.)* K0VLA and W0NRW both passed the ICS300 course in Fremont on February 9-10. K0VLA, W0NRW, and WB0VNF will be attending an Emergency Management meeting on March 12 at the Police Station.

PUBLICITY: W0NRW reported that the meeting notice was printed in the *Fremont Tribune*.

OLD BUSINESS: None.

NEW BUSINESS: WB0VNF reported that the DMR repeater currently at the home of Arnie Grubbs, KA0NCR will be moved to the Gifford Towers by George Blessing, KC0HYI and will be on 444.850 (-). The rent will be \$50 per year to the Fremont Housing Authority. They will take down the other antennas and other equipment that is there. KB0ZUN moved that since PARC pays the rent for the KD0EFC repeater on the other tower we should pay the rent for this repeater. K0OM seconded the motion, which passed.

DRAWING: The winner of \$10 was Jake Jacoby, KC0QDH.

ADJOURN: The meeting was adjourned at 736 PM.

Larry had purchased some items from Schulman Auction, in Kansas City, that were delivered by Gary, WAØJRM. We eventually located Gary, so I went with him to his vehicle to retrieve the items and load them into my truck. In addition to Larry's goodies, Gary had an additional item for another ham. A very large, heavy Hallicrafters receiver. I know, because Gary asked if I could lift it, since his back was bothering him. I did and carried it to the hams vehicle. After getting it, almost on his back seat, it was evident it would not fit, so back out it came, to be placed in his trunk. It was heavy and awkward to maneuver!

We spent most of the day at the 'meet & greet' table. Around 1:00 pm, we decided we had enough fun there, so decided to head back to have more fun!

Back at my south drive, I pulled up to his truck, got my towing strap out, and discovered my truck did not have tow hooks on the front. Backed out of the drive and backed up to his truck. I started providing 3 weather briefings a day at the EOC that continued through Friday, March 22. I also answered weather questions and handled most of the coordination with the NWS. The EOC grew to as many as 25 people at times. Four members of an EOC support group came in from Lincoln with Mark Hosking, Deputy Director of Lincoln/Lancaster Emergency Management, in charge of the EOC. They gave Tom Smith a chance to get some sleep and to organize the EOC in a way that would function efficiently and also provide documentation for later reimbursement from FEMA. The four of them left on Thursday, March 21, but they also trained their replacements while they were here, using local Fremont people. Tom Smith continued in over-all charge of the Operation.

Throughout this, I was coordinating with Ed, K0RPT, the ARRL Nebraska Section Emergency Coordinator. Through him we arranged for Lance, WU0Q to assist us on Monday, March 18, after he was able to make it across the Platte at North Bend and reach us via a county road. Lance, WN0L and Darlene, N0LOP were also able to make their way into Fremont and assist us.

It was difficult to communicate in/out of the temporary EOC with hand-held Ham radios, so either K0VLA or myself stepped outside when communication was required. We also used cellphones and text messages. That is a separate issue that I will address at a later date.

The reason for asking K0VLA to originally activate the OMMRS equipment was to act as a good base station. He had good coverage using the 146.67 repeater, but he did find a problem with the antenna on the roof which will need to be addressed at a later date.

As the Flood Operation continued, it became apparent that regular communications were doing a good job and we were there as a back-up. It also became apparent that the Hams were doing a great job as volunteers who also just happened to be Ham operators. Their actions are a story that can be told later as I do not know all the details yet, but they are impressive so far.

The EOC closed at 5 PM on Friday, March 22, as the disaster transitioned into recovery mode. However, several of the Hams are still volunteering in the positions where they found they had skills.

On a personal note, in my career in the NWS, I supported EOCs many times, but this is the first time that I actually operated in an EOC. It has been an educational, enlightening, and rewarding experience. I have been doing something that I thought might be making a difference in my own town with my own friends. I am sure that is true for all the volunteers in general and specifically the Ham volunteers.

Since the rains have returned to the area on Saturday, March 23, I will be collecting rainfall reports as usual on Sunday, March 24, and on into the future. Plus, we are available for communications support as always.



Thank you to everybody who was able to assist in this Disaster, knowing full-well that many more wanted to help but it was impossible to get here for a few days.
