New FCC Application Fee Will Not Apply to Amateur Radio License Upgrades

The Federal Communications Commission (FCC) staff has clarified in response to an ARRL request that the new \$35 application fee will not apply to most license modifications, including those to upgrade an amateur radio licensee's operator class and changes to club station trustees. The FCC staff explained that the new fees will apply only to applications for a new license, renewal, rule waiver, or a new vanity call sign. As previously announced, the new fees take effect on April 19, 2022.

"We are pleased that the FCC will not charge licensees the FCC application fee for license upgrade applications," said ARRL Volunteer Examiner Coordinator (VEC) Manager Maria Somma, AB1FM. "While applicants for a new license will need to pay the \$35 FCC application fee, there will be no FCC charge for future upgrades and administrative updates, such as a change of mailing or email address. Most current licensees, therefore, will not be charged the new FCC application fee until they renew their license or apply for a new vanity call sign."

ARRL previously reported that the new \$35 application fee for amateur radio licenses will become effective on April 19, 2022. Further information and instructions about the FCC Application Fee are available from the ARRL VEC at <u>www.arrl.org/fcc-application-fee</u>.

History Of A Ham

I have been interested in electronics since high school. I built several Heathkit projects including the Heath AR3 receiver. It was not much more than a 5 tube table radio but it gave access to the Ham

Bands. I hung a piece of electric fence wire from the bedroom window to the chicken house and the race was on. After graduation I moved to Omaha to attend classes at the Radio Engineering Institute located on Leavenworth Street for 2 years and learned a lot about electronics. During that time I went to work for the Telephone Company and found out how much I really did not know.

In 1965 the company moved us to Grand Island. I was still listening to the AR3. After getting settled, I met some folks from the G.I. radio club and joined up. Then I got more serious about a ham license and finally passed the code for a Novice license in 1966. That license was for one year and could not be renewed. That meant that you needed to upgrade to General class within one year. The AR3 retired to a shelf when I bought a Lafayette HA-350 receiver and a Knight T60 transmitter. That combination allowed me to get to the 13 wpm required for the general. After passing the General I drove to Council Bluffs bought a used Hallicrafters HT-37 from Word Radio labs that gave me to access to SSB. While we lived in G.I. I became guite active in the club. Some club members worked at the FCC monitoring station and were a great resource for a new ham and I appreciated that.

One day I got a phone call from the big boss asking if I would be interested in an interview for an engineering job in Omaha. I made a trip to Omaha. A few days later I got a call from my new boss asking if I could spell engineer. Guess I passed. We moved back to Omaha in 1972.

I joined the Aksarben club and had a lot of fun doing the usual ham stuff. Packet, 2Meter repeaters, DX, field day and the usual nets. During the early 80s I was invited to attend a PARC field day.

It was held in a large machine shed out East of Fremont but I do not remember the exact location. There I met K0sw and a bunch of local hams. I brought along my Drake Twins set up for CW. K0SW and I took turns logging for each other and we had a lot of fun. I really never liked doing the manual dupe sheets. I thought it was a royal pain. Computers and N3FJP did the ham world a great service.

PUBLIC NOTICE

The FCC released a ***Public Notice*** on March 23, 2022, stating that the amateur radio application fees, including those associated with Form 605 application filings, would become *effective on April 19, 2022*. The Federal Communications Commission's authority to impose and collect fees is mandated by Congress.

The \$35 application fee, when it becomes effective on April 19, will apply to new, renewal, and modification applications that request a new vanity call sign. The fee will be per application.

Administrative updates, such as a change of name, mailing or email address, and modification applications to upgrade an amateur radio licensee's operator class*, will be exempt from fees. (*this new information was just confirmed by FCC staff on Tuesday, March 29.)

VECs and Volunteer Examiner (VE) teams will not have to collect the \$35 fee at exam sessions.


